Keep your member number handy. You'll also need to have your mobile number or email address registered on your account.

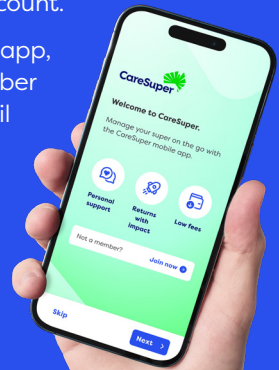
