PROTECTING YOUR PRIVACY

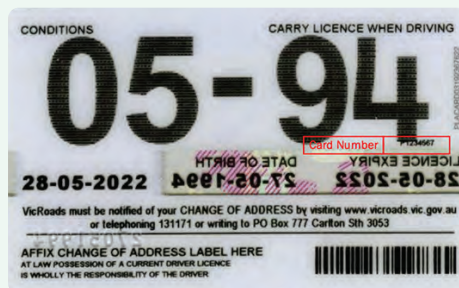

Step 1

TAKE A PHOTO OF YOUR ID

Take a clear photo (or scan) of your **driver licence (both sides), passport or proof of age card**.



ACCEPTED IDENTIFICATION

We'll accept an Australian passport that's expired within the last 2 years. Foreign passports must be current and, if not written in English, will need to be translated by an accredited translator. We'll accept an original document or certified copy of the translation.

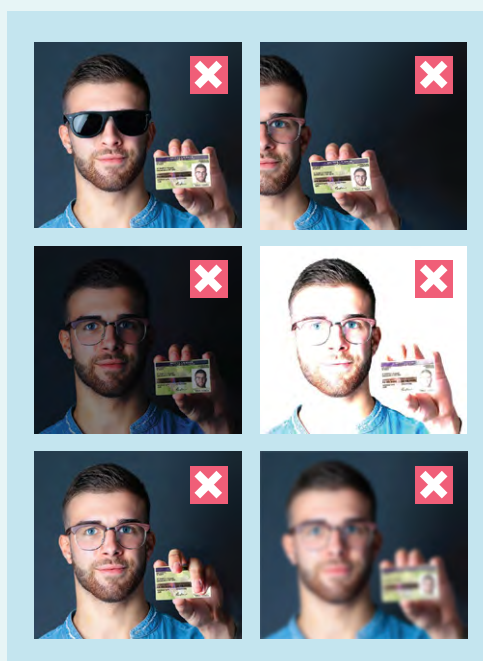
A Proof of Age card must be issued by an Australian state or territory with your name, photo and signature.

Step 2

TAKE A PHOTO OF YOU HOLDING YOUR ID

Take a well-lit, clear photo of you holding your chosen ID. Please make sure we can clearly see your face and easily read the details on your ID.

Handy tip: Despite being called 'selfie ID' it's best (and easier) to have someone else to take this photo of you.



A photo will be rejected if your face or information on your ID are not clearly visible.

Please avoid photos where your face or ID are blurred, out of focus, obscured or cropped off.



Step 3

SECURELY UPLOAD YOUR PHOTOS

You can upload your photos in the Contact us section in your **MemberOnline** account at caresuper.com.au/login, or by heading to caresuper.com.au/getintouch.

IMAGE FILE FORMAT AND SIZE LIMITS

Your photos need to be **.jpeg**, **.jpg**, **.png** or **.pdf** files. When using the Contact us section in **MemberOnline**, you can upload six files at a time (max 10MB per file, or 14MB combined).

When using our 'Contact us' page, you can upload one file at a time (max 2MB per file).
